Hello, Fellow Travelers! My name is Marilyn N, and I'm an alcoholic. My sobriety date is January 4, 1999, and what an adventure it's been! I got sober in Northern Virginia and Southern Maryland where my first service job was greeting people as they came in the door for meetings. I graduated to making

coffee and doing meeting set-up. They even trusted me with the key to church!

I've moved several times in sobriety and found that jumping into A.A. immediately is the best way to keep my sanity and make a ton of new friends. When I moved to Fort Collins, I started working a two-hour shift at Central Office each week answering phones, helping people find meetings and answering questions from newcomers and families about the AA program. I helped start a new women's step meeting (Women Stepping Up) that meets Thursday evenings. We have had good attendance since the beginning, providing the opportunity to refresh our acquaintance with and share our varied experiences with these crucial steps for successful recovery. Recently, I was elected as a Member-at-Large of the Intergroup Steering Committee, and have been on the group planning this year's gratitude event – An

Evening of Gratitude – scheduled for November 12th at Club Tico in City Park. What is Intergroup???

Intergroup has been formed so that each group may elect a representative from their group to participate in monthly business meetings with other group representatives. Each month they share their group's experience in carrying the A.A. message, lets all the members of Intergroup know how their home group is doing: numbers of attendance, when and where they meet. The Intergroup representative keeps their group informed about what Central Office is doing, as well as the other groups. Make sure your group has a vote and a voice! Intergroup helps the next alcoholic and the Central Office.

All actions of the Northern Colorado Intergroup shall be guided by the Twelve Traditions, Twelve Concepts, and the A.A. Service Manual.

Governed by the By-Laws and Amendment documents.

STEP - Sought through prayer and meditation to improve our conscious contact with God as we understood Him, praying only for knowledge of His will for us and the power to carry that out.

TRADITION - Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films.

CONCEPT - The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.

PRINCIPLES: Spirituality \triangle Attraction \triangle Respect

A.A. Quote for November:

"Time after time newcomers have tried to keep to themselves certain facts about their lives. Trying to avoid this humbling experience, they have turned to easier methods. Almost invariably they got drunk. Having persevered with the rest of the program, they wondered why they fell. We think the reason is they completed their housecleaning. They took inventory all right, but hung on to some of the worst items in stock. They only thought they had lost their egoism and fear; they only thought they had humbled themselves. But they had not learned enough humility, fearlessness and honesty, in the sense we find it necessary, until they told someone else all their life story.

More than most people, the alcoholic leads a double life. He is very much the actor. To the outer world he presents his stage character. This is the one he likes his fellows to see. He wants to enjoy a certain reputation, but knows in his heart he doesn't deserve it."

sober AA's who have gone before us.




It is easy to let up on the spiritual program of action and rest on our laurels. We are headed for trouble if we do, for alcohol is a subtle foe.



Payroll Detail - For Reference

The July/August 2023 finance report included the 2nd Quarter federal and state payroll taxes and liabilities for April, May, June 2023.

The **state withholding** that comes out of the gross pay was paid August 2nd, which was **\$306**. Every employer is obligated to remit all payroll liabilities, what comes out of an employee's gross pay, to the IRS & State every quarter.

The Office Manager gross salary is \$32,206.68 for 28 hours/week. The monthly gross is **\$2,683.89**; net is \$2,096.49.

Q2 gross salary --> \$2,683.89 x 3 = **\$8,051.67**

The **employee FICA** is 7.65% of the above amount = **\$615.95** for Q2 (which is a payroll liability NCIG is "obligated to remit" as part of the gross salary) and the employee federal withholding is \$804 -- totaling **\$1,419.95**.

In 2023, the FAMLI Colorado (Initiative) started and is 12.08 per month of the gross pay. In Q2, 12.08 x 3 = 36.24. This is also part of the Payroll Liabilities.

NCIG's (the employer's) FICA is also 7.65% of the gross pay amount for Q2 (\$8,051.67), which is exactly the same as the employee's FICA): \$205.32 x 3 = \$615.95 for Q2. This is the "Payroll Taxes."

The federal (and state) monthly payroll liabilities and taxes are paid by our accountant every quarter.

SELF-SUPPORT


